

COVID-19 - Coronavirus disease 2019 NORTH MACEDONIA FLASH UPDATE 15 3 April 2020

Data as reported by authorities by 22:00, 3 April 2020

HIGHLIGHTS

- 46 new cases reported; 430 the total number of registered COVID-19 patients; 67 patients are currently hospitalized at CID 10 have severe clinical manifestations. 2 patients have recovered and are discharged from CID in good health. Sadly, North Macedonia announced one COVID-19 fatality 69-years-old patient from Tetovo. The total number of affected medical staff is 52, i.e. 12% of all reported cases, out of which 34 have acquired the infection while in their primary clinics.
- More movement restrictions hours in Kumanovo Curfew hours during the weekend (21:00 on Friday-05:00 on Monday) and during the workdays from 16:00-05:00.
- IMF approved rapid financing in the amount of €175.2 million for economic measures for health and macroeconomic stabilization, and the balance of payments arising from the coronavirus pandemic.
- The Government adopted the Decree for procurement of emergency 200 ventilators. All treatment costs related to COVID-19 will be universally covered for all regardless of employment and health insurance status.
- Much-loved children's authors are joining an initiative to read extracts of their books to millions of children and young people currently living in isolation amid the COVID-19 pandemic. Figure 1. North Macedonia – Cumulative confirmed COVID-19 cases (n=384) by 3 April 2020 18:00





Figure 2. North Macedonia -COVID-19 incidence per 100,000 people, as of 3 April 2020



The highest cumulative incidence is in Debar 176,5 cases per 100,000 people, followed by 59,6 cases per 100,000 people in Kumanovo and 33,7 cases per 100,000 people in Skopje.

Age of patients vary from 2-91 years. However, the highest risk groups are between above 50 years old.

RISK ASSESSMENT OF COVID-19 IN NORTH MACEDONIA ACCORDING TO GEOGRAPHICAL SPREAD

According to the WHO risk categorization, Debar, Skopje and Kumanovo are in Phase 4 (widespread community transmission) and the rest of the Republic of Northern Macedonia is in phase 2 (sporadic cases).

Coronavirus disease 2019 (COVID-2019), Europe

- Based on the WHO and ECDC data as of 3 April 2020 10:00 CET, the WHO European Region number of cases is representing over 56% of the global burden to date. Globally, USA carries the heaviest case load (213 600), with Italy and Spain concluding top-3. Overall, five more countries from the European Region are in top-10 (Germany, France, United Kingdom, Switzerland, and Turkey);
- In Europe, Italy has the highest case count (115 242 cases, 21%), followed by Spain (110 238 cases, 20%), Germany (79 696 cases, 15%), France (58 327 cases, 11%), and the United Kingdom (33 722 cases, 6%). Five other countries reported more than 10 000 cases (Switzerland, Turkey, Belgium, the Netherlands and Austria), while another 16 countries in the Region reported 1000 cases or more, listed in descending order (Portugal, Israel, Sweden, Norway, Czechia, Ireland, Russian Federation, Denmark, Poland, Romania, Luxembourg, Finland, Greece, Iceland, Serbia and Croatia);
- 74% of the global burden of COVID-19 deaths have been reported in the European Region, with Italy and Spain (13 917 and 10 003 COVID-19 deaths, respectively) accounting for roughly 65% of all deaths in Europe, followed by France, United Kingdom, Netherlands, Germany and Belgium.

WHAT WHO IS DOING FOR COVID19 IN NORTH MACEDONIA?

In line with the strategic shift of the Government's approach in fighting COVID19 whereby efforts are put on increasing testing, maintaining quality COVID19 care and essential care and protecting health care workers, WHO works closely with the government and national and global health partners to enable the response.

WHO action in COVID-19 outbreak in North Macedonia aims at limiting the virus spread, protecting health and the health workers at the frontline, preserving the health care system capacity and its sustainability to respond and provide essential services to the population.

WHO is the lead UN agency for Health and main technical and health policy advisor to the government on COVID-19 containment and mitigation.

WHO works in coordination closely with other UN agencies as per the UN reform.

Western Balkan including North Macedonia is one of the priority countries for the WHO European Region.

Technical support, guidance and assistance are provided through the WHO Country Office from all levels of the Organization.

There is abundance of technical guidance WHO has developed in all areas of work: we are supporting the country to develop technical plans and implement priority interventions in the framework of a strong nation-wide strategic response.

- Establishing bilateral partnerships, resource mobilization, and joint plans to address gaps and needs of the MOH.
- Sustaining professional and technical knowledge of all health care workers in the country through
 the online WHO training course for COVID-19 for health care and infection control and protection
 (IPC) is now available in Macedonian Language on the WHO learning platform for Health workers.

- Generating Robust data needed to show which treatments are the most effective, by North Macedonia joining the WHO SOLIDARITY Trial which is a large, international therapeutic study that will allow also receiving free of charge medicines for COVID19 and latest evidence-based indications for changing treatment protocols when needed to reduce mortality, length of stay under mechanical respiration and reducing complications.
- Tracking the epidemiological spread of the virus, supports early warning system and keep communities and frontline responders informed with the latest technical guidance.
- Contributing to the UN in the country to make sure that timely procurement takes place and supporting the newly set UN coordination mechanism for the COVID19.

- WHO continuing the roll out of the Partners Platform for the Strategic Preparedness and Response Plan (SPRP): Onboarding has taken place supporting North Macedonia to link with international support; the Country Preparedness and Response Plan has been uploaded for increasing capacity for 2000 COVID19 cases.

- SPRP includes health systems continuity, the Platform will have a 9th Pillar for assessment of priority actions to maintain essential health services.
- WHO developed a risk assessment tool to be used by health care facilities with COVID-19 patients. The tool is to be completed for all health workers who have been exposed to a confirmed COVID-19 patient in a health care facility. The tool will help determine the risk of COVID-19 virus infection of all HCWs who have been exposed to a COVID-19 patient and then provides recommendations for appropriate management of these HCWs, according to their infection risk.
- WHO also held on Friday 3 April 2020, a **Zoom training session in Macedonian language** open for **all Health Care workers dealing with COVID19** for the proper practices in Infection control and prevention of virus transmission in hospitals.

HEADS UP on WHO FRONT

- WHO is preparing the 2nd Strategic Preparedness and Response Plan: The plan will build on the first SPRP to incorporate what we know now and the evolving global context. The strategies for preparedness and response remain the same.
- WHO is preparing to scale up laboratory diagnostic capacity: GeneXpert: A test for the COVID-19 coronavirus developed by Cepheid for their GeneXpert instrument has received an Emergency Use Authorization by the US Food and Drug Administration (FDA) on 22 March 2020. WHO is currently working to negotiate access to this test.
- Rapid communication on the role of the GeneXpert® platform for rapid molecular testing for SARS-CoV-2 in the WHO European Region link

NORTH MACEDONIA STRATEGIC RESPONSE AND ACTION

North Macedonia mobilized an all-of-government action to fight this new coronavirus, including scaling up emergency response mechanisms in all sectors. Actions and readjustments of measures are continuous and monitoring of the situation is ongoing on daily basis. The country is in declared national emergency Announced by the President of the Republic on 18 March 2020 for one month.

On the health front, the country is working hard now to ensure its COVID19 hospitalization surge capacity with the necessary personnel are in place with the influx of additional cases in recent days.

Several measures are taken to interrupt human-to-human transmission including reducing secondary infections among close contacts and health care workers, preventing transmission amplification events, and preventing further spread.

The Ministry of Health increased public health measures, such as rapid identification, diagnosis and management of the cases, identification and follow up of the contacts, infection prevention and control in health care settings, implementation of health measures for travelers, awareness-raising in the population and risk communication and counter misinformation as well as minimizing social and economic impact through multisectoral partnerships.

Today:

 The Government adopted the recommendation of the Commission for Infectious Diseases and recommend all health professionals from Kumanovo who are currently working in other cities to be at disposal of the General Hospital in Kumanovo. Infectious diseases specialists from Kriva Palanka and Kratovo will be identified to work in the Center for Public Health in Kumanovo.

- The adjusted restriction of movement hours is not applicable to the police, army and health professionals (in public and private health sector including the family doctors). The pharmacies will also be operational. For agricultural activities, movement within the territory of the villages is permitted exclusively for working purposes.
- The Government adopted a Decree on financial support of independent artists during the state
 of emergency, which regulates the financial support of independent artists for April and May 2020
 in the amount of 14.500 mkd.
- Inspectors continue with intensive field surveillance in order to ensure full compliance with the Government's measures and recommendations related to COVID-19 – a total of 5 213 inspections were carried out and the general conclusion is that most entities respect the Government's measures for prevention of coronavirus.

COVID-19 UN AND PARTNER COORDINATION

To provide a comprehensive and coordinated approach in identifying and repurposing the available bilateral assistance to the COVID-19 response, all public administration bodies receiving bilateral donor assistance will report promptly to the Secretariat for European Affairs (SEA) the amount of funds available for each project. The SEA will then submit a formal request to the bilateral donors for the reuse of funds in accordance with the identified priority needs for COVID19.

- North Macedonia to receive urgent medical equipment with 4 million euros from EU for procurement through UNOPS.
- USAID to support both WHO and WHO with 1.1. million USD in their efforts to fight the epidemic in North Macedonia
- Germany offered support to the Ministry of Health with an amount of USD 2 million in PPE
- OSCE is proposing donation of essential PPE for the COVID19 Center of Infectious Diseases for 30,000 Euros.
- Packages with food and hygiene assets in the amount of 100.000 USD will be allocated to most jeopardized Roma families in Macedonia that are socially and economically hit by the health crisis, announced the Foundation Open Society Macedonia which donated the funds.
- Macedonian Red Cross supports the elderly and the disabled in shopping and basic needs for hygiene, protection and their livelihood.

The above is not a comprehensive list.

GAPS/NEEDS AND CHALLENGES

The most important priority at this point and in the next 3 months is to ensure that the health system can cope with increasing numbers of cases needing intensive management and also protecting the health care workers.

> Critical needs:

- Laboratory Kits and reagents; Personal Protective Equipment (PPE); Mechanical Ventilators/Respirators (respirators from operating rooms are not adapted to need of respiratory diseases and cannot be used for the ICU);
- intensifying risk communication;

- socioeconomic relief for vulnerable groups and employement protection.
- Maintaining Essential health and social services
- Protecting health care workers whether those working in the COVID-19 designated facilities or elsewhere countrywide because of the community transmission.
- Mental Heath Support

> Challenges:

- Procurement: Access to local or international supplies and mainly respirators for the critical needs identified because of international shortages.
- Shortage in health workforce if the situation progresses
- Ensuring sustainability of the health facilities and health care during and after the crisis.
- outreach activities for the vulnerable
- Ensuring continuity of treatment and access to regular health care for all citizens including the vulnerable groups with other diseases and pathologies.
- Fighting Isolation and community engagement
- Compliance of the citizens to instructions of the government and self-isolation.
